Pageant Rules for Junior Miss Marshall County held on October 4, 2008 at 7:00 PM.

Sponsored by the Marshall County Chamber of Commerce.

1. Contestants must be a resident of Marshall County.
2. Contestants must be between the ages of 13 and 15. (On or before Oct. 4th).
3. Ten applicants are needed in order to hold the Junior Miss pageant.
4. You will need to bring an extension cord, power strip, small mirror, chairs, and possibly a small table (such as a T.V. Tray). Two large rectangle tables will be set-up in the dressing room; however, space will fill up quickly.
5. The contestant may have one person backstage to help them dress.
6. The contestant will be given two passes, one for the contestant and one for the dresser.
7. Pictures will be made Monday, September 22, 2008 at 7:00 PM. During this time we will answer any questions you may have. This is a mandatory. We must have the name of your sponsor by this day. Split sponsorships will be accepted as long the business is a chamber member. (Parents may be sponsors, but will not be allowed to include their business name unless they are a member of the chamber). Pictures will be made at the Chamber of Commerce at 227 Second Avenue North, Lewisburg.
8. The first practice date will be announced on the day of pictures.
9. The contestants will be judged on age appropriate casual wear and formal wear. Stage presentation and poise will be factored in as well. A list of questions will be given out at the last practice for the top five.
10. The winner of Junior Miss Marshall County will hold the title for one year and will assist with the Miss Marshall County Pageant in July in 2009. The winner may compete in other Junior Miss competitions, but will not be eligible to compete in Miss Marshall County until 2010. The winner may participate in area parades and make appearances at the Chamber December Meeting and July Business Meeting.
11. In the event that the Junior Miss Marshall County moves out of town, the first runner up will assume the title.
12. Cost to attend the pageant at the door will be \$8 for adults; \$5 for students, \$3 for small children . **Advance tickets for sale at the Chamber will be \$6 for adults; \$3 for students, \$1 for small children, starting August 18, 2008.**
13. Cash awards for the top five are as follows: Junior Miss Marshall County: \$125; 1st runner-up: \$100; 2nd runner-up: \$75; 3rd runner-up: \$50; 4th runner-up \$25.
